- I. CALL TO ORDER: At 6:00 p.m. Larry Duncan, president, called the meeting to order. A. ROLL CALL:
 - 1. MEMBERS PRESENT: Clinton Arbuthnot, Larry Duncan, Tyler Gibson and Kay Maes
 - MEMBERS ABSENT: Rick Birdsong
 Kay Maes made a motion to excuse the absence of Rick Birdsong. Clinton Arbuthnot seconded the motion. Motion carried.
 - 3. SCHOOL PERSONNEL PRESENT: Richard Hargrove, Kyle Lasley and Pam Hartley
 - 4. GUESTS PRESENT: None
- II. ADDITIONS TO THE AGENDA: Superintendent Hargrove requested that APPROVE SUBSTITUTE be Added to NEW BUSINESS, Item B.
- III. APPROVE THE AGENDA: Tyler Gibson made a motion to approve the agenda with the addition of APPROVE SUBSTITUTE to NEW BUSINESS, Item B. Clinton Arbuthnot seconded the motion. Motion carried.
- IV. ROUTINE ITEMS:
 - A. APPROVE THE MINUTES OF THE January 22, 2018, Regular Meeting: Clinton Arbuthnot made a motion to approve the minutes of the January 22, 2018 Regular Meeting as presented. Tyler Gibson seconded the motion. Motion carried.
 - B. FINANCIAL REPORTS: The financial reports included in the February Board Packets did not reflect complete information. The % of budget spent was not calculated. Superintendent Hargrove distributed updated copies of the January financial reports. The board reviewed these financial reports.
 - C. CLAIMS PAYABLE February 19, 2018: Kay Maes made a motion to approve the February claims payables as presented. Tyler Gibson seconded the motion. Motion carried.
- V. PUBLIC COMMENT: Deb Sharpe highlighted several Springfield Preschool updates. She reported that the entire staff was elated and relieved to receive NAEYC notification. Their hard-work, dedication and perseverance paid off. The second TS Gold checkpoint has been completed and reports cards were shared with parents during the child's parent-teacher conference. A local donation has been used to purchase new rocking chairs for the preschool, and will also be used for some fence repairs. Child Find will be held at the preschool on March 1 and 2 and Cooking Matters courses will be offered soon. Due to historically low attendance, Parenting Classes are currently on hold. Preschool staff will be attending the Early Childhood conference over spring break.

Mrs. Sharpe reported that the STA concession raised over \$1,800.00 that will be donated to the Marlinda Packard Medical Fund. The STA scholarship rubric has been sent to the paper for publication and the scholarship recipient plaque in the high school foyer has been updated. Two baby showers will be hosted by the STA, one for Mondragon baby on 2/28/17 and the other for Reid baby on 3/7/17. On behalf of the STA officers, Mrs. Sharpe shared their concerns in regard to school safety and interest in working with the board to address related issues.

A. DISCUSS AND APPROVE CASB POLICY JKA-E-2: Mr. Hargrove explained that Policy JKA-E-2 is not required by law, but he would recommend the adoption of the policy. Tyler Gibson made a motion to approve CASB Policy JKA-E-2 Complaint Procedures and Regulations Regarding the Use of Restraint or Seclusion. Kay Maes seconded the motion. Motion carried.

- A. FIRST READING CASB POLICIES January 31, 2018: Superintendent shared that the general change in these policies is the replacement of all references to NCLB, No Child Left Behind, with Every Student Succeeds Act. He will study the policies completely to determine any other changes and will share those at the next regular board meeting. He recommended putting the policies into first reading. Clinton Arbuthnot made a motion to approve first reading of CASB Policies, January 31, 2018. Tyler Gibson seconded the motion. Motion carried.
- B. APPROVE SUBSTITUTE: Mr. Hargrove recommended that Sara Coleman be approved to be added to the Substitute Teacher list for the district, pending the completion of licensing requirements. Kay Maes made a motion to approve Sara Coleman as a substitute teacher for Springfield School District. Clinton Arbuthnot seconded the motion. Motion carried.

On behalf of Kathy Self and the Springfield chapters of FCCLA and FBLA and in recognition of Career and Tech Education Month, Mr. Lasley shared activity update reports provided by Mrs. Self, highlighting recent FBLA & FCCLA activities. He also noted the date and extended an invitation to the board members for the FFA RM Oyster Fry and Hired-hand sale scheduled for March 1. Mr. Lasley reviewed some of the items listed on the Jr/Sr High Board Report included in the board packets.

$B. \ \ SUPERINTENDENT/ELEMENTARY \ PRINCIPAL \ REPORT-RICHARD \ HARGROVE$

Mr. Hargrove reviewed each of the items on his February BOE report in the board packets and shared additional information on some of the items. In regards to the large increase in CSDSIP premiums he explained that all pool participants are receiving the same increased amounts. Due mostly to the increase in large claims this last year and noted that premiums had remained fairly stable for the past several years. Springfield's increase will be approximately \$9000.00 higher than the 2017-18 total premium. He also told the board that the district has been notified of another upcoming audit. This audit will be over October Count, At-Risk and Transportation.
